Acting on behalf of Portman Lights Sp. z o.o. (Ordering Party) we would like to inform you that due to the expiry of the deadline for submitting offers under the name: "Purchase of a comprehensive service for the construction of the Portman Lights stand together with a project for the Prolight & Sound 2022 Messe Frankfurt fair" as part of the project "Pomeranian Export Broker. Comprehensive system of supporting exports in the Pomeranian Voivodeship ", co-financed by the European Union, implemented by the Ordering Party under the Agreement No. UDG-PBE.03.2019 / 213 concluded with Agencja Rozwoju Pomorza S.A. on April 13, 2022, in accordance with the submitted Inquiry 1/2022 of April 4, 2022, the offers were opened.

The awarding entity selected the most advantageous offer from among the offers submitted by contractors meeting the conditions for participation in the procedure, based on the evaluation criteria specified in the inquiry. After evaluating the submitted offers, the following tenderer was selected:

The price for the realization of the subject of the contract proposed by the aforementioned tenderer was: **EUR 12,339.28 net**. After the Ordering Party has assessed the criteria adopted for this Order in the Inquiry, this offer received the highest number of points. The contract performance price proposed by this tenderer was the lowest.

The Ordering Party, based on the bid selection criteria set out in point VII of the Inquiry, awarded the following scores to each of the bids received:
